I (We) further hereby agree to indemnify and hold Our Savior's Lutheran Church, its volunteers, agents, affiliates and successors (collectively, the "Indemnities"), harmless from and against any and all claims, demands, actions, lawsuits and liabilities, including attorneys' fees and expenses sustained by the Indemnities as the result of the negligent, willful, or intentional acts of the undersigned and/or participant (under 18 or 18 and older).

Furthermore, I (we) understand that the undersigned and/or participant (under 18 or 18 and older) may be required to provide written reference(s) regarding character, physical health and/or mental health. Participation in a Christian Action or Our Savior's activity may be refused or denied to participant by Our Savior's Lutheran Church, its staff and volunteers at any time and Our Savior's Lutheran Church, its staff and volunteers will not be liable if the undersigned and/or participant (under 18 or 18 and older) fails to cooperate with the rules and that any infraction of the rules may result in immediate dismissal from the event or activity at my (our) expense.
